Thank you for taking our dogs out on a PUPcation! A PUPcation is when a dog is taken off-site for a day for a walk or adventure, an extended stay for a couple of days, a weekend or a week, and the returned to the site where a dog is being fostered or boarded. Please read and abide by the following rules. Place your initials on each line after reading.

Dogs can only be walked by persons 18 years of age or older.

Dogs must remain on a short leash at all times when not inside an enclosed structure (a secured fence, house or building). While in public areas (parks, walking tracks, or an area other than the applicant's personal property), the dog leash must be held securely using leash loop at all times.

Do not allow any interactions with other animals, without prior approval by the PUPcation coordinator, and after proper introductions have already been successfully made with the other animal.

Dog must not be left unattended inside a vehicle.

Dog must not be left unattended inside a building or structure that is not temperature-controlled, or tethered outside by a chain or tie out cable.

Dog must be picked up and dropped off at the agreed upon dates and times and within the stated hours of operation of the boarding facility if the dog is being boarded.

A text must be sent to the PUPcation coordinator when the dog has been returned.

A PUPcation report card must be completed and emailed to the PUPcation coordinator within 72 hours after the completion of each PUPcation.

Photos and/or videos will be taken of the dog engaged in activities as the opportunity arises during the PUPcation, and emailed to the PUPcation coordinator for use on social media and other means to provide information about the dog. Please don't send photos/videos including children unless you are their parent/guardian.

Angels to the Animals, Inc. shall not be responsible for any damage or injury to persons or property that may be caused by the dog while it is in my care.

When transporting a dog inside a vehicle, the dog must be secured inside your vehicle using a crate, dog seatbelt or tether.

If the dog becomes sick or injured, you must immediately contact the PUPcation coordinator.

As a participant in the PUPcation Program, I agree to the following terms and conditions:

1. I am at least 18 years old, and I have read and understand the rules and requirements of the PUPcation Program as provided herein by Angels to the Animals, Inc.
2. I agree to provide a safe, clean, comfortable and temperature-controlled environment for the dog in my care, and to comply with all State, county and municipal laws and ordinances and all pertinent regulations pertaining to animal care and welfare.
3. I understand that rescue dogs may have unknown medical, behavioral and/or emotional issues, and I agree to provide the necessary care and attention to manage these issues as directed by the PUPcation coordinator.
4. I understand that dogs can be unpredictable, and may bite or cause injury. I assume all risks associated with the dog while it is in my care. I agree to take reasonable precautions to prevent such incidents, including but not limited to, keeping the dog on a leash or inside a crate when necessary, and warning others that the dog may bite.
5. In the event that the rescue dog bites a person or another animal while in my care, I assume full responsibility for any and all damages, costs or liabilities arising from the incident. I agree to indemnify and hold harmless Angels to the Animals, Inc., its agents and volunteers from any and all claims, damages or liabilities arising out of the incident.
6. I understand that Angels to the Animals, Inc. is not responsible for any damages, costs or liabilities arising from my participation in the PUPcation Program, including any injury, illness or damage caused by the dog.
7. I understand that the dog remains the property of Angels to the Animals, Inc., and I have no ownership rights or claims to the dog.
8. I agree to return the dog to the assigned foster or boarding facility at the agreed upon date, time and location, or earlier if deemed necessary by the PUPcation coordinator.
9. I understand that Angels to the Animals, Inc. has the right to terminate my participation in the PUPcation Program at any time and for any reason.
